Below is an extract of information provided by IFRA in relation to types of application present in each IFRA Category.

| IFRA Category 1 | Lip Products of all types (solid and liquid lipsticks, balms, clear or colored, etc.); Childrens toys |
| IFRA Category 2 | Deodorant and antiperspirant products of all types including any product with intended or reasonably foreseeable use on the axillae or labelled as such (spray, stick, roll-on, under-arm, deo-cologne, etc.); Body sprays (including body mist) |
| IFRA Category 3 | Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, eye pillows, etc.) including eye care and moisturizer; Facial make up and foundation; Make-up remover for face and eyes; Nose pore strips; Wipes or refreshing tissues for face, neck, hands, body; Body and face paint (for children and adults); Facial masks for face and around the eyes |
| IFRA Category 4 | Hydroalcoholic and nonhydroalcoholic fine fragrance of all types (Eau de Toilette, Parfum, Cologne, solid perfume, fragrancng cream, etc.), aftershaves of all types (except creams and balms); Fragranced bracelets; Ingredients of perfume kits and fragrance mixtures for cosmetic kits; Scent pads, foil packs; Scent strips for hydroalcoholic products |

| IFRA Category 9 | Bar soap; Shampoo of all types; Cleanser for face (rinse-off); Conditioner (rinse-off); Liquid soap; Body washes and shower gels of all types; Baby wash, bath, shampoo; Bath gels, foams, mousses, salts, oils and other products added to bathwater (such as bath bombs); Foot care products (feet are placed in a bath for soaking); Shaving creams of all types (stick, gels, foams, etc.); All depilatories (including facial) and waxes for mechanical hair removal |

| IFRA Category 12 | Candles of all types (including encased); Laundry detergents for machine wash with minimal skin contact (e.g. Liquid tabs, pods); Automated air fresheners and fragrancing of all types (concentrated aerosol with metered doses (range 0.05-0.5mL/spray), plug-ins, closed systems, solid substrate, membrane delivery, electrical, powders, fragrancng sachets, incense, liquid refills (cartridge), air freshening crystals, solid non aerosol car diffuser); Air delivery systems; Cat litter; Cell phone cases; Deodorizers/maskers not intended for skin contact (e.g., fabric drying machine deodorizers, carpet powders); Dry cleaning kits (placed in the dryer); Dryer sheets and fabric softener sheets; Fuels; Insecticides (e.g., mosquito coil, paper, electrical, for clothing) excluding aerosols/sprays; Joss sticks or incense sticks; Dishwash detergent and deodorizers – for machine wash; Olfactive board games; Paints; Plastic articles (excluding toys); Scratch and sniff; Scent pack; Scent delivery system (using dry air technology); Shoe polishes; Rim blocks (toilet); Toilet gel; Scent beads |
